and to this purpose self-certifies and declares, by taking on all civil and penal responsibility in case of misrepresentation, that:

-She/He has read and perused the Randonnée's details on the relevant webpage and, therefore, to be aware of the track, altimetry, hardship and perils; to be therefore aware of the the risks she/he is taking by participating in complete autonomy as if it was a personal trip and to taking on those risks, including minimal rest, night ride, possible presence of animals on the track, possible unfavourable weather conditions, orientation challenges, physical and mental fatigue, discomfort, injury; **and of being aware and willing to take on the risk that she/he could get injured and/or incapacitated in a place where medical assistance could not be fast enough to prevent physical harm, including fatal damage.**

- He/She has therefore considered to be in possession of enough personal experience and psycho-physical autonomy in order to manage the challenges that may arise, including lack of water and food supply, lack of shelter, lack of rest, including in time of adverse weather conditions and at night time.

- She/He has read and perused the **Randonnée Brevet Regulations** on the relevant webpage and accepts all rules with no reservation.

- She/He has read and perused the **A.R.I. Regulations** and accepts all rules with no reservation.

-She/He is aware of the lack of technical support and assistance (including health assistance) and that she/he is aware that controls only serve the purpose of verifying the whether the track is being followed correctly and that, in case of withdrawal, return to the start should happen autonomously.

-She/he has checked the status of the breaking system and in general of the bicycle and of being the sole holding responsibility for it.

-She/he acknowledges the Organizer's right to modify the track and/or cancel and/or stop the Randonnée in case needed.

-She/He exempts, due to long distances, the Organizer from any systematic and continuous control over the track

-She/He recognizes the Organizer's right to use, at no cost and with no geographical or temporal constraints, any picture or video of the undersigned taken during the event.

-She/He acknowledges that the Organizer's only obligation is that of setting up controls and validating the undersigned result for obtaining the Brevet.

-She/He acknowledges that the Organizer has no responsibility, neither contractual nor extra-contractual, on potential material damages and financial losses caused or suffered by the undersigned before, during and after the Randonnée.

-She/He acknowledges that the Organizer and its collaborators have no responsibility on any damage, injury or loss suffered by the undersigned regardless of the factor causing them.

-She/He acknowledges that the Organizer and its collaborators should not be charged, including of legal costs, for any damage and/or loss and/or injury suffered by third parties due to the undersigned behaviour.

-She/he is aware of her/his duty to **respect the Rules of the Road** and she/he will adapt the breaking and lighting system accordingly.

- She/he is aware of her/his **duty to wear the safety rigid and homologated helmet** during the whole duration of the Randonnée, to respect the set maximum average speed and to promptly communicate an eventual withdrawal or delay at any check point to the Organizer, being aware that in case of lack of communication, the public force would be alerted at the undersigned's responsibility and cost.
